On behalf of the Board of Trustees of the Community Foundation of Greater Rochester I am happy to inform you that Thaar Care Foundation (Grantee) has been awarded an advised Grant from the Brendan Davis Memorial Foundation Fund. Grantee Requirements:

Tax Status: Grantee is either a tax-exempt organization as described in Section 501(c)(3) of the Internal Revenue Code of 1986, has received an IRS determination letter that qualifies it as a public charity, and has not received notice of any change in its tax-exempt status, or is a governmental entity or political subdivision of the State of Michigan. Further, Grantee is registered with the Michigan Attorney General to solicit donations in Michigan or is exempt from registration.

Use of Funds: This grant may only be used for charitable purposes as defined under the Internal Revenue Code, specifically for Mental Health and Suicide Prevention Education and Resources. Funds may not be used to influence legislation, the outcome of any election, to carry on a voter registration drive or lobbying activity.

Compliance: Failure to adhere to all of the Grantee Requirements will impact Grantee's grant eligibility for a period of 18 months from the date of this Agreement or through the end of the next calendar year, whichever is later. Grantee's requirement to provide a Progress Report is mandated by the Community Foundation.

Acknowledgement: By endorsing, depositing, cashing or otherwise negotiating the enclosed check the Grantee agrees to be bound by the terms and conditions of this Grant Agreement.
